Maria Leonard, Department of Management lecturer and Sam Walton Fellow, received the 2019-2020 UTRGV Student Organization Advisor of the Year Award for her outstanding mentoring and leadership of VCOBE student organization ENACTUS. ENACTUS has been actively serving the local



community through multiple initiatives such as the Thanksgiving Food Drive, Personal Financial Planning Training, and the Sustainability Ambassadors Program. Using the UN 17 Global

Sustainable Development Goals as its guide and with 72,000 students in 1,730 campuses worldwide, Enactus' mission is to "engage the next generation of entrepreneurial leaders to use innovation and business principles to improve the world."

He has chaired 14 doctoral dissertation committees and served as a member on 21 others. Dr. Escobari has published 21 papers with 14 doctoral students. EVENTS AND COMMUNITY ENGAGEMENT

Business Plan Presentations



In collaboration with the UTRGV Entrepreneurship and Commercialization Center (ECC), **Professor Sylvia Robles** hosted Business Model Canvas Virtual Final Pitch "Adopt a Startup at UTRGV" presentations for the students in her Foundations of Entrepreneurship course. A panel of judges evaluated the presentations. The "IQ's Juice Bar" and "Caballero Barber Supply" business plans were selected as the winners and each received a free incubation service at the UTRGV ECC.

Personal Financial Planning Training

Sponsored by the State Farm grant to teach high school students and the Wells Fargo grant to teach college students, the VCOBE **ENACTUS**, mentored by **Professor Maria Leonard**, and **the Economics Society**, mentored by **Professor Jorge Vidal**, have been providing personal financial planning lessons to high school and college students in the Rio Grande Valley. They will continue offering these classes in fall 2020.



Colombian Leadership and Change Education Training

Maria Leonard, faculty member at VCOBE Department of Management and Sam Walton Fellow, traveled to Bucaramanga, Colombia, last march to deliver a face to face training to a group of 28 people on teaching the course in Leadership and Change, developed by Linda Matthews, Jorge Gonzalez, and Maria Leonard. The engaged group ranged from administrators, faculty, deans, and graduate students of the Universidad Nacional Autónoma de Bucaramanga (UNAB), and members of the business community of this city. They will now be responsible to teach this course to local executives. Students who take this course, which is currently also being developed as a Quality Matters-certified online course, use the Mixed Reality Simulation (MRS) method to apply their newly-acquired knowledge on leading radical change in organizations.



Sustainability Ambassadors Project

Under the supervision of **Professor Maria Leonard, VCOBE Enactus** partnered with the UTRGV Office of Sustainability and HEB to teach sustainability and triple bottom line concepts to a group of at-risk teen moms in PSJA ISD. In the fall of 2019, our Enactus chapter developed a seven-week program in which these students attended sessions related to personal sustainable practices such as personal finances, education, renewable energy, environmental issues, and food insecurity, as well as participating in academic excursions highlighting organizations who champion sustainability in the Rio Grande Valley. Every part of this program incorporated one or more of the triple bottom line concepts: people, planet, and profit. The young women who participated were asked to apply these concepts to their own lives. On the last day of the program, a group of experts was invited to judge their presentations. And the top three participants received scholarships to further advance their academic efforts.





Sylvia Robles, Department of International Business and Entrepreneurship lecturer, participated in the First International Council for Small Business (ICSB) Special Certificate on Teaching Sustainable Development Goals (SDGs) Program organized by the United Nations (UN) and ICSB in May 2020. On June 10, 2020, she presented the "Adopt a Startup at UTRGV" during an ICSB webinar to promote the teaching of UN SDGs and has received more than five proposals to collaborate with faculty from Nigeria, Mexico, Colombia, Kenya and

South Africa.

Redesigning Restaurant of the Future

The Restaurant Finance and Development Conference has invited students from UTRGV and three other leading Hospitality and Tourism Management programs to research and present a business concept for a Restaurant of the Future. As COVID-19 has forced the Food and Beverage Industry to rethink their current business models, this student competition will give the students an opportunity to present their creative ideas in front of the Restaurant Finance and Investment audience. The UTRGV team. under the

mentoring of **Dr. AJ Singh**, consists of two undergraduate and two MBA students who are working this summer to prepare their pitch, for the conference to be held between November 9-11 in Las Vegas.
